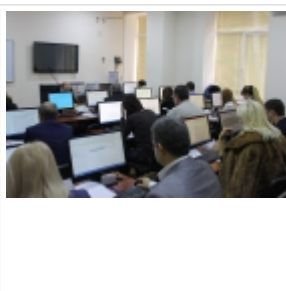
Dear Advocates

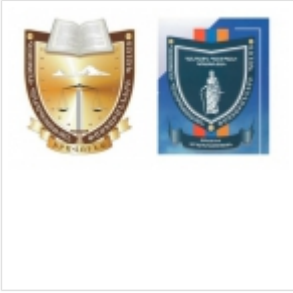
