the Chamber of Advocates of the Republic of Armenia invites you to take part in the **retraining lectures of February 2017**. Taking into account the fact that the lecture will mainly take place at the end of the working day the Chamber of Advocates of RA will treat you with coffee, tea and light food.

- P.S. By the Decision of the Council of the Chamber of Advocates of RA from 21.12.2016 num. 26/5-L changes and amendments were made to <u>the order of advocates' retraining</u> that mainly refer to the following:
- 1. During **two years** the advocates have to retrain at least four hours in the frames of confirmed topics of Deontology subject (rules for advocate's behavior), instead of previously confirmed **one year.** The estimation of the two years' time period begins from the 1-st of January 2017.
- 2. By means of the Internet (by watching the lecture, that was recorded beforehand, within the defined borders) all the advocates are able to participate in the retraining, though not more than 4 (four) hours each term, except for the advocates mentioned in the 11-th clause of the same order, who applied beforehand in order to fulfill all the retraining hours on-line.
- 3. Based on the advocate's application equal to the participation in the retraining lectures will be considered the advocate's professional scientific studies or the publishing of a textbook or a manual, as also the participation in a conference on a condition that the Council of the Chamber of Advocates that has organized the Scientific and Methodological committee approves the advocate's application. The committee mentioned in this very clause is formed of three advocate members and is valid during two years.
- 4. The Chamber of Advocates of RA also does not impose administrative liability on advocates who failed to participate in the retraining:
- if they present an appropriate document to the lecturers of state or accredited non state higher educational institutions.
- to persons preparing disciplinary work .
