

## THE ADVOCATES ALSO JOINED 'HAYASTAN' ALL-ARMENIAN FUND'S DONATION INITIATIVE

**"We are our borders. All for Artsakh"**

Advocates, not only with their professional mission, but also with public initiatives, constantly involved in solving the problems facing Armenia and Artsakh.

**On October 2, 2020, 3,709,000 (three million seven hundred and nine thousand) AMD** assistance was provided to the Artsakh Republic in the form of pre-arranged food from the common funds received from the Chamber of Advocates, the School of Advocates, advocates, law firms, the French-Armenian benefactor Raymond Yezeguelian, as well as 12 French-Armenian advocates.

During this time, transfers were made again by French-Armenian benefactor Raymond Ezegelyan, cording to him, as well as the law school transferred 500,000 AMD to the donation fund. The Board of the Chamber of Advocates also directed the budget of 1,200,000 AMD provided for the New Year event for advocates to the donation fund.

The Board of the Chamber of Advocates, by unanimous decision No. 20-L of October 9, 2020, decided to transfer **5,500,000 (five million five hundred thousand) AMD** from the donation fund to "Hayastan" All-Armenian Fund.

Please be informed that the total amount of assistance already provided by the RA Chamber of Advocates is **9,209,000 (nine million two hundred nine thousand) AMD**.

Once the remaining funds of the donation fund are replenished, they will also be used for charitable purposes.

**P.S.** Surb Harutyun (Holy Resurrection) Church of Parakar also joined the initiative of the Chamber of Advocates of RA, providing 1,000 kg flour, which was handed over to the Artsakh representation in Armenia.

Many of the advocates directly addressed their support to 'Hayastan' All-Armenian Fund, Artsakh.

At the forefront are also advocates whose family members are in contact with the staff of the Chamber of Advocates.
